When Social Hits the Fan: How to Prepare for and Manage a Social Media #FAIL

Social media has changed how organizations must plan for and react to crises. Most organizations, however, do not have a reputation management strategy and aren't prepared to manage a potential PR nightmare that starts on one online site, quickly expands to others, and jumps the fire line into business or even general news.

Learn about the changing dynamics social media has caused, such as how social media has affected the news media, how people interact, create community outrage, change expectations, etc. Also, how it is more important now than ever to be listening to the conversations.

I will share the building blocks essential for a solid plan, including the importance of monitoring your brand and listening to social media as an early warning system and a means of sampling community sentiment.
